XI. CHIEF EXECUTIVE OFFICER'S REPORT

Angus shared the following from his report:

- Fresno EOC has taken on the responsibility to be the Regional applicant for the 2020 Census and coordinating the efforts of Census in Fresno, Tulare, Kings, Kern, Inyo and Madera counties. If you have any questions, please contact Elizabeth Jonasson. Elizabeth announced her new staff, Garbrielle Rivas, Content and Community Engagement Specialist.
- Fresno EOC is working with the CA Poverty Task Force to breakdown the silos in place due to the State or Federal regulations and guidelines.
 - Fresno EOC will be opening a LGBTQ Center in March 2019.
- Fresno EOC will be providing transportation to our behavioral health clients and our staff will be trained to complete an intake assessment of our clients directly into our behavioral health system.
- Access Plus Capital will be entering the development field and moving beyond small business financing to moving into commercial and development financing.
- Advancing technology has developed in a Blockchain of artificial intelligence in creating and identifying people who they are for greater ease of referrals and joint services for our clients.
