- C.3. Employment and Training 2019 DOL Re-Entry Employment Opportunity Solicitation Proposal (Ready4Work)

Jeff Davis explained that the grant would serve adults aged 25 and over, county-wide. This is the 4<sup>th</sup> time the grant has been submitted. Staff is optimistic that the new structure of the proposal to include partnerships will make it more competitive. We are submitting as an Opportunity Zone which will provide more points. He also discussed the difference between Promised Zones and Opportunity Zones.

C.4. Energy Services - DAP Solar Program and Resolution

David Wear explained the two phases of the program. Last year Fresno EOC was allocated \$12.5 million and installed 650 systems in the pilot phase. The pilot phase used only 6 agencies, this next phase will use agencies statewide. The new allocation is \$2.5 million of a total of \$9 million allocated to the state. Commissioner Robles asked about the effect on property values. Discussion followed. There was discussion around outreach and how the houses are prioritized. Wear and Angus explained that applications are taken by LIHEAP during normal intake. The applications go through a point system that takes into account the size of the utility bill – how much of an "energy burden" there is, if there are any medical issues in the household and a basic "first in, first served" plan.

- C.7. Planning and Evaluation, 2019 CSBG Discretionary Fund and Resolution 5% of the statewide CSBG funds are put into a discretionary account for emergencies. If there is no emergency, the funds are distributed to all agencies equally. Our allocation will be used to increase the infrastructure of the agency.
