VIII. A. 3. Indirect Cost Rate Submission - Final and Provision Rates Rebecca Heinricy reviewed the process of submitting the proposal. The ICR is used to allocate all of administrative expenses that benefit all the programs in the agency. Based on our final audit, the rate submitted is 7.5%. This amount is also submitted as our provisional cost rate based on our proposed budget for 2019-2010. We have been consistent over the last few years with no need to go back and re-evaluate and "true up". There are certain costs, such as WIC vouchers and bus passes that are not allowed in the computation and must be taken out. Also costs that would essentially be calculated twice are removed, such as interagency services and admin fees. Head Start regulations state that salaries (and benefits) over \$189,500 are not to be included in the computation. Some programs have caps on the percentage of indirect costs. CSBG funds are used to fill the gaps created by those caps.

VIII. C. 8. Planning and Evaluation - Community Action Plan (CAP)

Katy Adams, Planning and Evaluation, explained that the 2 year CAP plan is a requirement from CSD. It is a way to evaluate our programs to make sure we're targeting the correct people, that we have financial systems in place and we're using the correct strategies. Our 5 year agency strategic plan is separate from this 2 year CAP plan.

VIII. C. 9. D. Rise Up Grant Application

Misty Gattie-Blanco introduced Jennifer Cruz, who has moved into the position of LGBTQ Director.

Received email confirmation that they received conditional award for both project grants. LGBTQ – Give Out raised over \$600 very quickly. Fireworks fundraiser will go toward LGBTQ program. Fireworks stand is at 2945 S Elm – TNT Warehouse. Open House date for LGBTQ Center will be distributed later.

EOC also has a number of initiatives that we are presenting to the DRIVE Committee: 2Gen, part of the Raising Children out of Poverty initiative; Workforce Education, providing internships to high-tech students; Green Economy – initially unsuccessfully pitched to TCC, focuses on putting resources in particular minority locations and creating interest in economy; and Community Health The process will begin on July 10 and should end in October to be ready to present at the

Economic Summit on November 7th.

There is money available to help organizations that do not have funds to send staff to participate in the process.
