### Background

The information presented below is intended to keep the Board apprised of rapidly changing local, state, and national issues relevant to our agency.

### Local

The long-anticipated move into the red tier has finally happened for Fresno County, precipitating the reopening of schools and businesses. While the pandemic is still not over, rising vaccination rates have contributed to lessening the infection rates in the county.

### Assistance

The City and County of Fresno are starting rental assistance programs with the recently approved federal funds. The funds target landlords who have to agree to certain provisions in order to receive back rent.

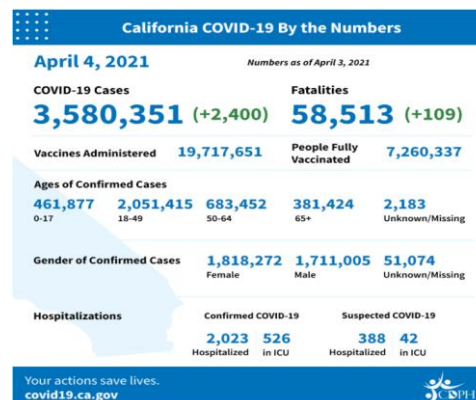
The County of Fresno is also using some of its CDBG funds to provide assistance to eligible utility bills in 6 communities (Fowler, Kerman, Kingsburg, Mendota, Reedley, Selma) and unincorporated areas of Fresno County. Fresno EOC is responsible for processing payments up to \$600 per eligible household directly to the utility.

### Schools

The majority of Fresno County schools have reopened with limited capacity and abiding by CDC recommendations to ensure the safety of children and staff.

### State

The State is expanding vaccine eligibility. Californians 50 years and older can get vaccinated as of April 1, and 16 year-olds and over can start getting vaccines on the 15<sup>th</sup>.



## Federal

The White House on April 1 announced the COVID-19 Community Corps as part of the “We Can Do This” initiative. The purpose of the Corps is to engage local leaders in campaigns to educate and encourage participation in vaccination efforts within their communities. Fresno EOC signed on to this initiative.

### Senator Padilla

As part of the Corps Network National Hill Day on March 18, LCC Director Shawn Riggins met with staff from Senator Padilla’s office, including Rebecca Kahn, who handles labor and HHS, and Sarah Swig, who addresses public lands and environmental issues. The call was in support of the proposed Civilian Climate Corps and the request for a potential carve-out for Corps.

Fresno EOC also participated in a press conference with Senator Padilla and Fellow CAP agency CAPK about Fresno EOC’s work during the pandemic, the increased needs of our community, and the potential benefits of the American Rescue Plan.

### Congressman Costa

Following the announcement on February 26 regarding the return of congressional earmarks, further guidelines regarding the “Community Project Funding” have been released.

Congressman Costa reached out to us to solicit project ideas for his list. We have worked with his office to submit four requests that are in line with the given criteria: USDA inspection kitchen, Gun Violence Reduction, Universal Basic Income for Youth Offenders, Forestry Corps.

Congressman Costa also spent some time on April 1 with our first in-person VAC cohort since the pandemic started. He shared inspirational stories and took questions from participants. The footage was then sent to media outlets.

### Budget

While a budget outline was expected by the end of March, the Biden Administration has yet to submit one to congress. Despite the delay, the House Appropriations Committee is still set on completing all FY2022 appropriations bills by the end of July. This budget will be coming amidst major policy and spending proposals that the administration has put forth.

### American Jobs Plan

Unveiled on March 31, the \$2.3 trillion dollar infrastructure plan includes funding to repair, replace and enhance our infrastructure, as well as plenty of funds for a range on tangentially related programs spanning transportation, caregiving, manufacturing, housing, schools, amongst other areas. To pay for the investments, the plan proposes tax increases that have already generated opposition from many Republican lawmakers. Some Democrats have criticized the bill for not doing enough to combat climate change. Despite the criticism, House Speaker Nancy Pelosi would like to see the bill passed by July 4.

Since it is expected to not have bipartisan support, it is likely that the legislation will attempt to be passed using the budget reconciliation process, requiring only 51 votes in the Senate. This will further exacerbate the divide between Republicans and Democrats.

The following excerpt from NCAF’s advocacy email details areas of investment included in The American Jobs Plan:

- \$111 billion for **water** infrastructure;
  - \$56 billion in grants, loans to states, tribes, and disadvantaged communities to improve water systems



- \$45 billion to replace all lead water pipes nationwide, including at 400,000 schools and child care facilities
- \$10 billion to monitor and remediate contamination by PFAS—often called “forever chemicals”—and for rural water systems
- \$100 billion to make **broadband access** universal;
  - Includes short-term subsidies for low-income households
  - Includes steps to make pricing more transparent and increase competition, including by prioritizing support for service providers operated by public entities, nonprofits, and cooperatives
- \$100 billion for **workforce development** programs;
  - \$48 billion for workforce development infrastructure and worker protection, including registered apprenticeships for underserved populations
  - \$40 billion for a new program to provide services for workers involuntarily unemployed and for training in high-demand sectors such as clean energy, manufacturing, and caregiving
  - \$12 billion for job training for women, people of color, and formerly incarcerated individuals
- \$400 billion for **caregiving for the elderly and those with disabilities**;
  - Would expand home and community-based services under Medicaid, including to support more pay and benefits for caregivers
- \$213 billion to build and retrofit more than 2 million **affordable homes**;
  - Providing tax credits, formula funding, grants, and rental assistance to expand affordable housing
  - Offering grants to jurisdictions that take steps to eliminate exclusionary zoning and land use policies
  - Investing \$40 billion in public housing infrastructure and \$27 billion in clean energy investments, including funding for the **Weatherization Assistance Program**.

### Immigration

Two key immigration bills passed the House on March 18; H.R. 6, the American Dream and Promise Act of 2021, and H.R. 1603, the Farm Workforce Modernization Act. Both bills await Senate approval. With the filibuster still in place, the bills would need 60 votes to move forward, and may have to wait until after the American Jobs Act is voted on.

The first bill would grant a pathway to citizenship for “Dreamers,” Temporary Protected Status recipients, and Deferred Enforced Departure beneficiaries. Several conditions would need to be met before the approximately 4.4 million immigrants that are projected to be eligible would qualify for permanent residence.

The second bill would allow farmworkers and their immediate family to obtain legal status through continued employment in the agricultural sector. It also proposes changes to the H-2A agricultural guest worker program.

### WIC Act

One of our legislative priorities, the Wise Investment in our Children Act (WIC Act), was re-introduced with bi-partisan support in both the House and Senate. The WIC ACT would: expand eligibility to age six or the start of kindergarten and extend postpartum eligibility and infant certification periods to two years.

#### Equity and Inclusion Updates

Over the past month, the Equity and Inclusion team has begun working with programs to align their work in Results-Based Accountability (RBA), which calls for accountability to both grantors and the specific needs of the community. We anticipate this will lead to adjustments in the ways programs operate, collect data, and analyze performance to make sure we have the most significant positive impact on the community.

Equity and Inclusion also held two events. In the first, speaker David Villarino spoke on Cesar Chavez Day. He discussed the importance of the labor movement and how that political thought, action, and analysis apply today. In the wake of several acts of violence against the Asian American Pacific Islander (AAPI) community, the Equity and Inclusion team held three open dialogue listening sessions for staff. In these sessions, they could express the emotional, social, and mental tolls the continued violence can have and ways to support each other as an organization. We also discussed our responsibility in addressing/responding to these instances of violence.

#### Head Start 0 to 5 Compliance

Agency win and great news! Head Start is no longer in a corrective action plan and is officially in compliance based on Office of Head Start performance and compliance standards. This is a significant win as it has implications for other programs such as Food Services, Health Services and accounts for over half of our agency staff.

## **Healthy Harvest/Cosecha Sana**

To date, we have received over 1,000 calls, and 97% of those have been for in-home quarantine support or rental assistance. As you know, on February 22, 2021, the Legislature passed Assembly Bill (AB) 85. This bill is an immediate action budget bill that provided an expansion of state funding for counties to offer wraparound services (including financial assistance) to agricultural workers self-isolating in hotels and those who choose to self-isolate or quarantine in their homes. Despite training for the county tracking system still being in progress with DPH, clients' financial assistance will begin the week of April 12. Clients who have tested positive or exposed within 30 days of contacting the agency are eligible.
