#### III. Approval of Minutes

The September 14, 2021 minutes were approved as read. M/S/C Starks/Metzler

#### IV. Chief Academic Officer/Principal Update

Michelle Tutunjian announced to the Council that Susan Lopez has been selected as the new Chief Academic Officer/Principal of Fresno EOC's School of Unlimited Learning, replacing Dr. Mark Wilson who retired last month. Tutunjian highlighted Susan's 20 years of experience in education, which includes teaching and administration.

#### V. Proposed Student Representatives

Rena Failla introduced the three student candidates to serve as student representatives on the Governing Council: Daniel Gamez, Leah Soliz and Sunshine Frausto. Each student shared how they found out about SOUL and how SOUL has helped them to progress towards their academic goals. A motion was made to accept the student representatives. M/S/C Metzler/Starks

#### VI. Membership Sub-Committee Minutes

Susan Lopez presented the Membership Sub-Committee Minutes to the Governing Council. The Sub-Committee reported that the current group of Council members satisfies the By-Laws representation requirements, however they continue to pursue participation from the juvenile justice system. A motion was made to approve the Membership Sub-Committee Minutes. M/S/C Starks/Davis

#### VII. Principal's Report

Susan Lopez shared SOUL's plans to prepare our seniors for graduation and post-secondary education. Approximately 30 students are completing the required registration and enrollment process to attend Fresno City College, with the help of Viviana Huerta who is very familiar with navigating through the online application. Sam Hairston and Jeff Davis shared about the Training and Employment, Out of School Youth Program and benefits to SOUL students.

Lopez, also highlighted the enrollment information and other activities as stated on the Principal's report.

#### VIII. Student Assessment Data

Rena Failla presented the North West Evaluation Association (NWEA) growth data results. While the results did reflect some increase the students who scored at or above grade level showed there is a need for additional support in Math. There was an increase in the percentage of students who met grade level standards in Language Arts between each of the administrations. Failla shared that SOUL is focusing on additional Math support to benefit our students.

#### IX. SOUL WASC Action Plan Update

Rena Failla presented the updates proposed in the WASC Action Plan. The goals have not changed since 2017, however, there have been minor updates highlighted in each of the goals: Goal 1, SOUL adopted a hybrid model of instruction with all students reporting to campus once a week to complete core classes and the opportunity to enroll in a classroom based elective which also meets once a week. Goal 2, the passage of AB 104 which provides a waiver for seniors who are behind in credits enabling them to complete their course requirements in a timely manner. Goal 3, in light of increased challenges presented by the COVID-19 pandemic, SOUL has increased its support staff providing our students with social/emotional learning opportunities and mental wellness support. Goal 4, Parent participation and involvement timeline dates were revised. A motion was made to approve the WASC Action Plan Updates. M/S/C Rodgers/Morales

#### X. Interact Club Update

Patricia Billeadeau shared that SOUL Interact Club is taking donations for the following: pumpkins, Christmas wreaths, Toys for Tots and backpacks. Painted pumpkins will be available at Fresno EOC on October 25<sup>th</sup> & 26<sup>th</sup>. Decorated Christmas wreaths will be delivered to the residents at the Health Care Center of Fresno on December 3<sup>rd</sup>. Toys for Tots will be distributed to students and their families. Backpacks will be given as graduation gifts to graduates on December 15<sup>th</sup> and 16<sup>th</sup>. The backpack will be filled with snacks, hygiene products and school supplies.

SOUL Interact Club is excited to donate \$500.00 of their project funds as an International project to St. Jude High School, Arusha, Tanzania, Africa. Larry Metzler asked that the Interact Club students develop a bulletin board that reflects their activities and community services projects.

#### XI. SOUL: Graduation 2021

Susan Lopez announced that SOUL's first December Commencement Ceremony will be held for approximately 30 graduating seniors on, December 15<sup>th</sup> and December 16<sup>th</sup> from 9:00 am – 3:00 pm both days. Each SOUL graduate will be honored with their own ceremony that will last approximately 15 minutes.

### **Recommended Action**

SOUL recommends Governing Council approval to adopt a plan on the use of the Educator Effectiveness funds authorized by Assembly Bill (AB)130 and amended by AB 167.

### Background

The sum of \$52,940 is appropriated from the General Fund to Fresno EOC SOUL for the Educator Effectiveness Block Grant.

SOUL, a charter school for Fresno Unified School District may expend the funds received pursuant to this subdivision from the 2021–22 fiscal year to the 2025–26 fiscal year. School districts, county offices of education, charter schools, and state special schools shall coordinate the use of any federal funds received under Title II of the federal Every Student Succeeds Act of 2015 (Public Law 114–95) to support teachers and administrators with the expenditure of funds received pursuant to this subdivision.

As a condition of receiving Educator Effectiveness Block Grant (EEBG) funds, Fresno EOC SOUL is required to:

- Develop and adopt a plan on or before December 30, 2021, delineating how the Educator Effectiveness funds will be spent including the professional development of teachers, administrators, paraprofessionals, and classified staff. The plan must be explained in a public meeting of the governing board before its adoption in a subsequent public meeting.
- On or before September 30, 2026, report detailed expenditure information to the department, including, but not limited to, specific purchases made and the number of teachers, administrators, paraprofessional educators, or classified staff that received professional development. The department shall determine the format for this report.
- The department shall summarize the information reported pursuant to subdivision and shall submit the summary to the appropriate budget subcommittees and policy committees of the Legislature and to the Department of Finance on or before November 30, 2026. The department shall determine the format for this report to

optimize its production within existing resources. The report shall be submitted in compliance with Section 9795 of the Government Code.

• Funding apportioned pursuant to this section is subject to the annual audits required by Section 41020.

### Conclusion

SOUL'S EEBG Expenditure plan was presented in a Public Hearing on November 30, 2021. SOUL'S EEBG Expenditure Plan reflects compliance mandated by the California Department of Education.

## EC 41480

(a)(2) A school district, county office of education, charter school, or state special school may expend the funds received pursuant to this subdivision from the 2021–22 fiscal year to the 2025–26 fiscal year, inclusive. School districts, county offices of education, charter schools, and state special schools shall coordinate the use of any federal funds received under Title II of the federal Every Student Succeeds Act of 2015 (Public Law 114–95) to support teachers and administrators with the expenditure of funds received pursuant to this subdivision.

(b) A school district, county office of education, charter school, or state special school shall expend funds apportioned pursuant to this section to provide professional learning for **teachers**, administrators, paraprofessionals who work with pupils, and classified staff that interact with pupils, with a focus on any of the following areas:

(1) Coaching and mentoring of staff serving in an instructional setting and beginning teacher or administrator induction, including, but not limited to, coaching and mentoring solutions that address a local need for teachers that can serve all pupil populations with a focus on retaining teachers, and offering structured feedback and coaching systems organized around social-emotional learning, including, but not limited to, promoting teacher self-awareness, self-management, social awareness, relationships, and responsible decision-making skills, improving teacher attitudes and beliefs about one's self and others, and supporting learning communities for educators to engage in a meaningful classroom teaching experience.
