**I. WELCOME AND CALL TO ORDER**

Shawn Riggins, LCC Director, called the meeting to order at 12:06 p.m.

**II. ROLL CALL**

Roll call was called.

**III. INTRODUCTION OF FRESNO EOC COMMISSIONERS ADVISORY BOARD MEMBERS**

Fresno EOC Commissioners Advisory Board Members, Ed Avila, LeRoy Candler, Brian King, Bruce McAllister and Lisa Mitchell were introduced along with areas they represent.

**IV. APPROVAL OF MINUTES**

No quorum. Approval of minutes tabled to next Advisory Board meeting on June 15, 2022.

**V. CHAIRPERSON SELECTION**

No quorum. Selection of Chairperson tabled to next Advisory Board meeting on June 15, 2022.

**VI. FRESNO COUTY FATHERHOOD INITIATIVE (POPS 2.0)**

Riggins provided background information on LCC's previous Proving Our Parenting Skills (POPS) program. Fresno County released grant application in early 2021, and LCC was awarded the contract in December 2022. POPS 2.0's Coordinator, Rita Stevenson, was hired in December and is currently interviewing for the Program Assistant and Transitional Support Advisor positions. The program is funded in partnership with the County of Fresno's Perinatal Equity Initiative and Babies First programs. The goals include promoting fatherhood involvement through classes on reproductive life planning, parenting skills and child development. LCC will provide services to at least 100 father/partners of African American mothers annually, using the 24/7 Dad curriculum. Program partners include LCC, Fresno EOC Adolescent Life Program, West Fresno Family Resource Center, Fresno County Department of Child Support Services, First Five of Fresno County and other EOC programs, including Employment & Training, WIC, and Head Start 0 - 5. Program funding is for three years with an option for a fourth year.

Riggins introduced Gifty Kwofie, Health Educator Perinatal Equity Initiative Coordinator with the Fresno County Department of Public Health Public Health Nursing Division. Gifty stated due to the need in the African American community to close the infant mortality gap in Fresno County, funding was set aside to implement programs such as the fatherhood program to provide partners of African American women with resources needed to support mothers. Gifty shared data, from 2013 to 2017, that compared the infant mortality rates by race/ethnicity between Fresno County and California. Data showed the mortality rate in Fresno County at 8.7% and California at 4.2%.

Riggins introduced Rita Stevenson, POPS Coordinator. Stevenson stated is excited about the program and that calls have started coming in. Stevenson shared her background is mental health treatment in young adults.

## **VII. ANNUAL CERTIFICATION REVIEW**

Riggins provided a brief background on the annual certification. Riggins stated every year the fourteen corps within the state of California undergo an annual certification review regarding performance during the grant year and is certified for the following year. The certification review is conducted by the California Conservation Corps (CCC). Shawn stated since he has been the Director for the past 12 years, and even before his tenure, Fresno has always had outstanding results. This year, LCC has been certified, but has been placed on a probationary status due to low attendance and not meeting the requirement of 50 corpsmembers per month, working 30 hours. Approximately four years ago there were a lot of programs throughout the state that were trying to access funds that were available to corps and the 14 corps directors began looking into how to ensure that the corps model remained intact and implemented a minimum for enrollment and attendance. The Pandemic and the competitive job market have impacted enrollment in the program.

## **VIII. PROGRAM UPDATES**

### **a. Work Training Projects**

A detailed list of work training projects was distributed at the meeting with the Advisory Board agenda packet. Several projects were highlighted. Riggins provided a brief update on LCC's activities/events since the last Advisory Committee meeting, as follows:

- Elisa Sgambellone, LCC Assistant Director and Ken McCoy, YouthBuild Charter School (YCSC) Registrar/Counselor, provided an update on the YCSC. On January 6, 2022, when COVID-19 numbers increased, YCSC students were shifted to remote learning as modified independent study students. Staff created learning logs and issued Chromebooks to students who then utilized Schoology to retrieve assignments and Google Docs to log in and receive attendance credit. Overall, YCSC's average daily attendance has been affected due to students leaving school for various reasons, one being for work opportunities at places such as Amazon. YCSC is actively seeking support of California Senate Bill 579 in Sacramento. If passed, this bill would provide the opportunity for schools to utilize the average daily attendance from 2019-2020, before the COVID-19 pandemic, for local control funding. YCSC staff is actively contacting former students to encourage them to return to school. Since the COVID-19 pandemic, the school is able to offer some flexibility and extend an opportunity to attend school part-time if they are working on a case-by-case basis.
- Julio Lopez, Recycling Program Manager, provided an update on LCC's recycling program. Lopez stated since the State of California opened up most business is experiencing an

increase in foot traffic. Recycling program continues to service the Save Mart Center during concerts and other events, the Friant Buyback Center has also seen an increase in the amount of California Redemption Value (CRV) being sold, averaging 4 truckloads per month. The recycling program recently partnered the Mattress Council and Republic Services Rice Road Recycling & Transfer Station, a fee-for-service project. This fee for service project contracts with LCC, 1 supervisor and 2 corpsmembers, to load mattresses and box springs on to a 53-foot trailer which is then taken to the mattress recycler.

- Riggins provided an update on the YouthBuild construction program. Staff is working on re-starting the Sterile Processing Tech program and will soon start placing students at Valley Children's Hospital for their internships.
- Riggins also provided an update on the Prop 68 project, the development of the second floor of the Paul McLain Vocational Building. Phase two and three should be completed within the next two weeks and prep work will begin on the elevator shaft. Once the elevator is installed LCC will have full access to the second floor and will be planning an open house sometime in September 2022.

### Background

The information presented below is intended to keep the Advisory Board apprised on the YouthBuild Charter School of California 2022 Graduation.

In 2009, Fresno EOC Local Conservation Corps (LCC) partnered with YouthBuild Charter School of California (YCSC) to provide the opportunity to complete a Western Association of Schools and Colleges (WASC) accredited high school diploma while enrolled as a corpsmember participant in LCC's job training program. Currently young adults, ages 18 – 29, may attend classes at the YCSC campus at LCC, or may pursue independent studies at the Owens Valley Career Development Center. Since Spring of 2020, YCSC has experienced and adapted to overcome and support students through the challenges of the global COVID-19 pandemic. The 2021 - 2022 school year will conclude with an in-person commencement honoring 15 students at Fresno EOC's Sanctuary Theater on June 24, 2022 and the final day of class on June 27, 2022. Enrollment for the 2022 - 2023 academic year will begin on August 8, 2022.

**Background**

The information presented below is intended to keep the Advisory Board apprised on the corpsmember and staff wages to address competition in the labor market.

On January 1, 2022, minimum wage in California increased to \$15 per hour. LCC corpsmembers earn minimum wage, with entry-level LCC supervisors and program assistants earning \$2 per hour more than corpsmembers. The nation-wide labor shortage has had a drastic impact on businesses and non-profits, all competing for entry level positions. Many local and national chain businesses routinely advertise starting pay around \$16 per hour (or higher). In California, many local corps programs are experiencing recruitment issues.

To address this, local corps programs have already implemented increased pay for corpsmembers, or are in the process of addressing this to assist with recruitment needs. On June 6, 2022, Fresno EOC's LCC adjusted the current starting pay for LCC corpsmembers (increased from \$15 to \$16 per hour) and LCC entry-level supervisors and program assistants (from \$17 per hour to \$18 per hour).

## B. Corpsmembers/Student Development

Corpsmembers are required to participate in continuing education at the Local Corps as a condition of their enrollment. High school diploma classes are available through the YouthBuild Charter School of California and college classes are available on-site through credentialed instructors assigned by State Center Community College District. Although the classes are intended for our corpsmembers, they are open to the entire community. Life skills classes are available to YouthBuild Fresno students on a by-weekly basis and available to all corpsmembers during the school summer and winter break annually.

The LCC/YouthBuild Charter School Senate Council provides corpsmembers with the opportunity to participate fully in the development of additional services and programs members may deem important to their experience and growth at the Corps.

**Activity:**

The YouthBuild Charter School of California (YCSC) continues to provide the high school education component, Life Skills, and Leadership Development for LCC. Currently there are 73 students enrolled.

- February 2022 – May 2022 - The YouthBuild/DOL Sterile Processing Tech class started. Three Corpsmembers completed SPT classes. Two Corpsmembers will begin 400-hour internship hours at Valley Children's Hospital. Start date to be determined.
- February 28, 2022 - Cohort 5 of the Central Valley Forestry Corps began Phase 1 of their training at the LCC. Phase 1 for this cohort differed from those in the past in that the four weeks were broken into two two-week periods before and after Reedley College's Phase 2 portion of the program. Phase one will be concluded upon the cohort's return to the LCC at the end of May.
- March 01 – 11, 2022 - Central Valley Forestry Corps participants participated in First Aid/CPR training, OSHA 10 and earned their certifications.
- March 11, 2022 -The first two weeks of Phase 1 of the Central Valley Forestry Corps at the LCC concluded. Participants moved on to Phase 2 at Reedley College where they received instruction in the classroom, as well as practical experience in the field.
- March 28 – April 08, 2022 - YCSC's Spring Break was filled with continuing education training opportunities for LCC corpsmembers. Participants were able to take advantage of the time off from school to earn their forklift and First Aid/CPR certifications, attend Career Prep Workshops to develop and create a résumé in partnership with Fresno EOC's Workforce Connection Young Adult Program, and attend a presentation from the CalCRG program's legal services provider. Corpsmembers attending the Career Prep Workshop also received a USB to store their résumé so it may be updated with new skills, training, certifications, etc. they receive during their term at the LCC.
- April 28, 2022 - LCC held its Quarterly Community Meeting. Corpsmembers and YCSC students listened to program announcements, received awards, were introduced to new staff, and enjoyed a refreshing treat.
- May 03, 2022 - Two LCC corpsmembers traveled with two LCC staff members to participate in the California Association of Local Conservation Corps (CALCC) Government Education Day in Sacramento. This year's Government Education Day was the first since 2019 and slightly modified from the traditional format due to the lingering effects of the COVID-19 pandemic. CALCC set up several tents on the Capitol grounds and legislators and/or their staff were able to walk around and visit booths to learn about all of the valuable contributions of corps around the state. LCC's two corpsmembers were able to share their stories and experiences at the Fresno corps and meet other corpsmembers from the 13 other member organizations. The experience of meeting with elected officials and their staff even inspired one of the LCC's participants to consider a future in public service!
- May 05, 2022 - For its final Community Action Project (CAP) of the 2021/2022 school year, YCSC students and staff partnered with LCC staff to bring the history and culture of Mexico alive. Among the activities enjoyed by the YCSC/LCC community were a poster making contest, history projects, music, dancing, and food. This CAP project marks a small-scale return to the in-person community events enjoyed before the COVID-19 pandemic.

- May 31, 2022 - Cohort 5 of the Central Valley Forestry Corps returned to the LCC after eight weeks at Reedley College to complete the final two weeks of Phase 1 of their training. Participants received instruction in the classroom and physical training to keep up with their conditioning for the transition to the field experience portion of the program. Participants traveled to Camp Sequoia Lake or the surrounding foothills to reduce potential fire fuel sources until early August.
- The 2020-2021 YouthBuild AmeriCorps Program was awarded 35 slots, 31 reduced half time, 2 half time, and 2 FT slots. Three (3) members are currently enrolled, 21 members earned an award, 11 did not complete. Enrollment is closed.
- The 2021-2022 YouthBuild AmeriCorps Program was awarded 35 slots, 31 reduced half time, two (2) half time and, and 2 FT slots. Seventeen members are currently enrolled in a 675-hour education award slot, two (2) are enrolled in a 900-hour education award slot. Fourteen 675-hour slots and two 1700-hours slots are available.
- AA/NA meetings continue on suspension until further notice due to COVID-19.
