New Fresno EOC Program Can Help You Pay Overdue Water Bills **NOW ACCEPTING APPLICATIONS**

If you are having trouble paying your water bill, a new program at Fresno EOC can help. The Low-Income Household Water Assistance Program (LIHWAP), operated by Fresno EOC is now accepting applications. The program can help families pay overdue water bills accumulated before and during the COVID-19 pandemic. The plan was introduced to ensure families have access to safe drinking water and wastewater (sewer) services.

LIHWAP is designated for households that are in danger of losing or have already lost their water services. The maximum benefit amount is \$2,000, and it is a one-time payment that will be directly applied to the homeowner's utility bill. But it's temporary, so there is a limited window of time for people to apply and benefits will be distributed on a first-come, first-served basis. The one-time LIHWAP program will end in August, 2023.

According to data collected by the State Water Resources Control Board, around half a million Californians experienced water shutoffs in 2019 due to nonpayment, and hundreds of water providers charge rates that could be classified as unaffordable for low income households. LIHWAP Director Gilda Arreguin says, "With rising prices on everything from food to fuel, low income households in rural and urban Fresno County face barriers in paying their water and sewer (wastewater) bills. We want to help with that expense, so households can continue to purchase food and cover unexpected costs."

Eligibility Requirements – <u>See website for full details</u>

- Households must meet the definition of being low income.
- Households must have a past due balance on their bill, also known as an arrearage. Applicants must provide a water bill, wastewater bill, or property tax statement with a past due amount.
- Client's water or wastewater system must be enrolled in direct pay. Payments will
 go directly to owners and operators of water systems and cannot be paid to
 customers.
- Households must subscribe to a community water or wastewater treatment system. Those with private water wells and septic tanks are not eligible for assistance.

time, Fresno EOC LIHWAP is only accepting applications from the residents in the cities that have been approved by the state. If your water system is not currently enrolled, please wait to sign up and contact your water system provider directly to enroll into the CSD LIHWAP direct payment program.
