**1. WELCOME AND CALL TO ORDER**

Shawn Riggins, LCC Director, called the meeting to order at 12:015 p.m.

**2. ROLL CALL**

Roll call was called.

**3. INTRODUCTION OF NEW MEMBERS**

New members not present at this time.

**4. CHAIRPERSON SELECTION**

Item tabled to next Advisory Board Meeting on May 17, 2023

**5. APPROVAL OF MINUTES**

No quorum. It was suggested that the June 15, and August 17, 2022 minutes be submitted to the EOC Board to accept, members agreed.

**6. TRANSFORMATIVE CLIMATE COMMUNITIES (TCC) SOLAR PROJECT UPDATE**

Shawn Riggins provided background information on the TCC Solar project. Riggins stated that a couple of years ago the City of Fresno received a grant to identify projects to invest in that would result in significant environmental and economic benefits in downtown, Chinatown, and southwest Fresno. Anyone who lived, worked, or owned property in these areas were encouraged to participate. At the conclusion of the process, 24 community projects, including a new satellite Fresno City College campus in southwest Fresno were selected for approval.

Jay Fitzpatrick, Solar Manager, provided an update on the program progress. Fitzpatrick stated that he has been working at the LCC since March 2022 training corpsmembers and serving people in this community to help them save money. The overall goal is to reduce the amount of greenhouse gasses produced in the TCC (southwest Fresno) area. Fresno EOC was approved for approximately \$3.2 million dollars to implement a Solar and Weatherization program. Through the EOC program, 170 homes in southwest Fresno will

be selected for weatherization/solar services, and some units may receive electrical car chargers. All homes that receive solar systems have to be certified by PG&E. In addition, staff ensures that the systems are running properly and that EOC is able to monitor them. Fitzpatrick also stated that staff is moving forward in securing additional homes to be weatherized in order to reduce the amount of electricity the home needs. The home is matched with a solar system to cover between 60 to 90% of the customer's electricity bill only. Corpsmembers are enthusiastic and eager to complete projects. Fitzpatrick also stated that it's becoming more difficult to find potential solar customers because the home has to be in good structural condition, the home must have a good roof and an up to date electrical panel that can handle the extra inputs the solar system requires. There is a program that assists homeowners in obtaining new roofs and new electrical panels, however, this takes time. Fitzpatrick stated that approximately 40 solar systems have been installed with a couple awaiting PG&E certification, and an additional 12 are in the pipeline. Each job starts as a weatherization job then the roof and electrical system is assessed. If they are in good condition, then solar system installation follows. Fitzpatrick stated that staff has been working with corpsmembers on basic skills such as getting to work on time, showing up every day, being a team player, building a resume, interview skills and job search skills. Fitzpatrick also mentioned that there are changes coming in the industry that may require that batteries be added to the solar systems.

Riggins stated that EOC's Energy Services department will be holding a Town Hall Discussion "Love Your Home" at LCC on March 1<sup>st</sup>. in order to increase program awareness and potential solar customers. Discussion followed on other outreach/marketing ideas and suggestions.

## **7. PROGRAM UPDATES**

### **A. Work Training Projects**

A detailed list of work training projects was distributed at the meeting with the Advisory Board agenda packet. Several projects were highlighted. Shawn Riggins provided a brief update on LCC's activities/events since the last Advisory Board meeting, as follows:

- Riggins provided an update on Prop 68-Development of the second floor of the Paul McLain-Lugowski Vocational Building, a 5,000 square feet space, includes 3 classrooms, an office and conference room. The state inspector was here on 2/14/23, temporary certification for the elevator was issued. The city inspection is scheduled for the week of February 20, 2023. Once this takes place, LCC will have access to the second floor, and will begin planning LCC's 30<sup>th</sup> anniversary celebration and grand opening, Advisory Board members will be invited.
- Riggins stated that two weeks ago EOC was contacted by Fresno County Supervisor Nathan Masig's office, who represents the Friant area. Drinking water in the area was affected by the recent rain in January, and residents have been placed on a boil water advisory. EOC responded to this request and the following day sites were set up in Friant for residents to pick up bottled water. LCC corpsmembers also distributed bottled water door to door. Approximately 1,000 cases of water were distributed. The media covered the water distribution.
- Riggins provided an update on LCC's YouthBuild (YB) DOL program. Riggins stated that the \$1.5 million YouthBuild DOL 2023 grant was submitted, if funded this will provide job training for 66 young people. LCC currently operates a YB grant building homes for low income residents in Reedley with Self Help Enterprises. Riggins stated the grant application included two additional components that were new for this round of funding, these components being solar and forestry training.

Riggins stated that two corpsmembers in the YouthBuild Sterile Processing Tech Certification training completed their internship at Valley Children's Hospital and have been hired. An additional four corpsmembers will begin their 400-hour internship shortly. The Sterile Processing Tech certification is recognized worldwide.

- Riggins also stated that the CalCRG grant application was submitted in January. This grant provides funding for mental health, substance abuse and legal services.
- Riggins stated the LCC will take the entire program to Yosemite National Park in May for an educational field trip. The LCC will be closed for the day, Advisory Board members are invited.
- Julio Lopez, Recycling Program Manager, provided an update on LCC's recycling program. Lopez stated the second quarter just ended and a report was submitted to the state, CRV collection increased in the second quarter. Approximately 3 - 4 truckloads of mattresses are being transported from LCC to the extraction/recycling site. The Rice Road project continues in collaboration with the Mattress Recycling Council. LCC was invited to assist in a waste tire event in Mariposa, the first time LCC has been contacted to collaborate with an out of county agency. Lopez also stated that CalRecycle contacted LCC in December requesting assistance in the clean-up of a 24-acre site in Riverdale that had been contaminated. LCC assisted in the clean up by collecting waste tires, three 48' trailers were loaded.
- Manny Brar, POPS Program Coordinator, provided an update on the LCC's County of Fresno Fatherhood project. Brar stated that 15 participants have completed the 24/7 Dad training and have graduated, cohorts 1-3, classes for cohort 4 will begin shortly. The program offers wraparound services. Outreach and recruitment is ongoing, a presentation was made to WIC clients; staff is working closely with other EOC programs; and the Family Resource Center and Babies First. The program is available for expecting, new and non-custodial parents, partners of African American Mothers and partners of women who receive services from Babies First. Classes continue via Zoom to accommodate working parents.
- Ken McCoy, YCSC Registrar, provided an update on the YouthBuild Charter School (YCSC). McCoy stated that 45 students are enrolled. McCoy introduced YCSC students, Guillermo Chavez and Aaliyah Johnson, both LCC corpsmembers. Students are leading school projects, Aaliyah is currently leading the Fashion Show that will take place February 23<sup>rd</sup>. The final trimester will begin after spring break. McCoy stated that attendance has been an issue due to COVID-19, illnesses and child care. Due to this issue, the school implemented flex scheduling, communication using the RemindApp daily, and the A vs. B Week attendance challenge. McCoy stated that this year the YCSC Fresno site has won more awards than in the last six years, and the most out of the entire YouthBuild Charter School system in California. Graduation is schedule to take place at the end of June.

#### B. Corpsmember/Student Development

- Both Aaliyah and Guillermo shared their experience at the school and LCC and stated that they are grateful for the opportunity. Aaliyah stated that the fashion show includes staff and corpsmembers, and looking for models to participate in the professional/business attire fashion show.

**Background**

The information presented below is intended to keep the Advisory Board apprised of the Local Conservation Corps (LCC) Sterile Processing Tech (STP) Certification Training Project.

In 2017-2020, Fresno EOC Local Conservation Corps YouthBuild Fresno was awarded the Department of Labor (DOL) grant that funds Construction and Sterile Processing Tech Certifications and hands on training. LCC was just informed by the Department of Labor that YouthBuild Fresno has also received the YouthBuild DOL grant for 2023 – 2026, providing training in construction, healthcare, and forestry for 66 young adults, ages 18-24. YouthBuild Fresno will once again partner with Amber Aquino, Sterile Processing Tech Instructor and Valley Children’s Hospital.

Young adults, ages 18-24, enrolled in YouthBuild Fresno and interested in a career in the medical field can participate in a 12-week Sterile Processing Tech class and may be placed in a hands-on 400 hour paid internship at Valley Children’s Hospital. Corpsmembers completing the 12-week SPT course and receiving hands on training will be prepared to take the state test for the Sterile Processing Tech Certification which is internationally recognized. YouthBuild Fresno is proud to announce that Valley Children’s Hospital has recently hired five (5) YouthBuild Fresno students into SPT positions at the hospital.

## B. Corpsmember Development Report

Recommendation: Information only

Background: Corpsmembers are required to participate in continuing education at the Local Corps as a condition of their enrollment. High school diploma classes are available through the YouthBuild Charter School of California or post-secondary education institution. Citizenship and



Leadership classes are available to YouthBuild Charter School students on a weekly basis and available to all corpsmembers during the summer and winter break annually.

The LCC/YouthBuild Charter School Senate Council provides corpsmembers with the opportunity to participate fully in the development of additional services and programs members may deem important to their experience and growth at the Corps.

**Activity:**

The YouthBuild Charter School of California (YCSC) continues to provide the high school education component, Life Skills, and Leadership Development for LCC. YCSC is nearing the end of the 2022 – 2023 academic year, providing high school education components, life skills, and leadership development for LCC. Applications are currently being accepted for the 2023 – 2024 school year that will begin on August 14, 2023.

- March 2023 - Four corpsmembers (4) completed OSHA 10 training and eight (8) completed FEMA ICS 100/IS700 training.
- March 6, 2023 - Two Corpsmembers began their 400-hour Sterile Processing Tech internship with a projected completion date of May 19, 2023.
- April 26, 2023 - Shyanne Seyler completed her 400 SPT internship and was hired at Valley Children's Hospital.
- May 19, 2023 - Demetrius Romero Sanchez will completed his 400-hour internship with Valley Children's Hospital and will begin his full-time permanent position with Valley Children's Hospital on May 15, 2023.
- April 25, 2023 - Vouchnai (Nai) Chheang completed her 400-hour SPT internship on Nai plans to job shadow the lead Valley Children's Hospital Pharmacist for a couple weeks, after will be starting college in the fall. Nai has a Bachelor's degree in Chemistry and plans to become a pharmacist.
- April 29, 2023 – LCC held its first Global Youth Service Day (GYSD) since 2019 when it was put on hold due to the global COVID-19 pandemic. For 35 years, GYSD has challenged youth ages 5 – 25 to put together or participate in projects that make a difference in their communities. This year, LCC and YCSC offered activities, games, food, and fun for the community. In addition, mattresses and electronic waste, or e-waste, could be dropped off to be recycled instead of ending up in a landfill.
- May 09, 2023 – Due to the lingering effects of a wet and snowy winter, LCC and YCSC's traditional trip to Yosemite National Park was changed to a trip to the coast. Corpsmembers, students, and staff were able to take in the sights and sounds of Monterey's Cannery Row and enjoyed a box lunch on one of its beautiful beaches. The trip was an educational one spent learning about the area's history, biology, and place in literature. There was even an opportunity to participate in a photography challenge by capturing photos of the day's sights.
- The 2021-2022 YouthBuild AmeriCorps Program enrollment closed August 15, 2022, 99% of the slots were filled. Five (5) corpsmembers remain active.
- The 2022-2023 YouthBuild AmeriCorps Program was awarded 35 slots, 31 reduced half time, two (2) half time and, two (2) FT slots. Member contracts are in review with YouthBuild USA AMC staff. Enrollment will begin once approval is received.

- During this reporting period an additional 11 participants completed all five modules in the Home Builder Institute (HBI) Pre-Apprenticeship Curriculum Training (PACT) and earned their industrial recognized certification.
- During this reporting period twenty-nine (29) corpsmembers completed First Aid/CRP Training, sixteen (16) completed forklift training.
- LCC continues to offer Career Prep workshops, in partnership with EOC's Workforce Connection Young Adult Program through March to all corpsmembers. Beginning in April, workshops are presented in-house, through LCC staff and partners. Topics include; Job Search, Interview Skills, Resume Writing and Mock Interviews.
- AA/NA meetings continue on suspension until further notice.
